ACWA has launched the election process for the 2026-'27 term for President, Vice President and region board members. This year, the election process for officers and region boards is combined. Voting for both sets of candidates will be done electronically by your designated voter on a single ballot. The electronic ballot will be received on July 21, 2025, and will include the names of all qualified candidates for both the Board Officers' Election and your Region Board Election.

Candidates for ACWA President and Vice President must be an elected or appointed director of an ACWA member agency. To become a candidate, the following must be submitted:

- Agency Resolution
- A Statement of Qualifications or Resume
- Abbreviated Candidate Statement
- A Headshot

Candidates for Region 9, the following items are required:

- A Signed Resolution
- Candidate Nomination Form
